SEMEN SALES AGREEMENT – 2021

I agree to the purchase of two (2) doses of semen to **MR FRITZWOOD**, at the price of **\$2,500.00**, for the breeding season of 2021, from Brazos Valley Equine Hospitals (BVEH).

1. This SALES AGREEMENT includes **two (2) breeding doses** of semen to **MR FRITZWOOD**, with each dose being eight (8) straws per dose. **NO LIVE FOAL GUARENTEE is to be included in this sale.**
2. Any doses requested after the initial shipment for the breeding season of **2021** purchased will be available to purchase at the price of \$500.00 per dose, eight (8) straws per dose.
3. Semen will be available to purchase at any time until the supply of frozen semen is no longer available. BVEH retains the ability to increase the price of the sale of the semen at the beginning of each breeding season.
4. A copy of the mare's registration papers must accompany this contract.
5. **The sale of the frozen semen does not include release fee and freight fee on any shipment or collection. There will be an added \$400.00 for release and shipment of frozen semen.**
6. A separate agreement is required for the professional services associated with breeding the mare at Brazos Valley Equine Hospitals, or for shipping semen.
7. Stallion services donated to stallion service auctions DO NOT include the collection/processing/freight of semen.
8. **It is the mare owner's responsibility to inform us of mare's pregnancy status.** If for any reason the mare does not become pregnant, the stallion owner/manager and Brazos Valley Equine Hospitals will NOT be liable.
9. BVEH will issue a Breeders Certificate for each live foal born as a result of breeding services herein provided once notified that the mare has foaled.
10. A Breeder's Certificate will be furnished to the Mare Owners upon notification of the birth of the foal. (All paperwork with all insemination dates from a licensed veterinarian on shipped semen contracts must have been properly completed and filed, and all bills pertaining to breeding and veterinary care paid in full).
11. It is understood and agreed that the stallion owner/manager and Brazos Valley Equine Hospitals will not be responsible for any disease, accident, sickness or death of the mare and her foal. A mare owner likewise will not be responsible for any disease, accident, sickness or death of the Stallion.
