2021 MARE – SHIPPED BREEDING CONTRACT

**Man Who Wouldbe King**

- 1. BRAZOS VALLEY EQUINE HOSPITAL, NAVASOTA, PLLC reserves **one breeding** for the mare:

(Enter mare’s registered name)

with a **Stud Fee of \$500**, payable to BVEH-Navasota, for the 2021 breeding season, Feb 1<sup>st</sup> to July 15<sup>th</sup>. A copy of the mare’s registration papers is required for this contract. If mare is being leased for breeding purposes, a copy of the AQHA lease agreement **MUST** be attached to the contract. The remaining balance of the Stud Fee and the first Semen Collection and Processing fee must be paid prior to collection of the stallion. **Semen will not be available without payment of the Stud Fee AND Semen Collection and Processing Fees.** The Stud Fee includes a live foal guarantee.

No chute fee will be charged. There is a Semen Collection & Processing fee of **\$400.00** per collection, which includes shipping via FedEx Priority. In the event that cooled semen should not be available, the mare owner will be offered frozen semen at the same cost. International shipments, including Canada shipments, will require a separate contract. All shippers must be returned within 4 business days, unless otherwise specified. Owner will be charged for the cost of replacing unreturned shippers.

- 2. This contract provides for one (1) Breeder’s Certificate. If multiple embryos are retrieved from one breeding, it will be the responsibility of the Mare Owner to notify BRAZOS VALLEY EQUINE HOSPITALS of number transferred.

- 3. Accounts will be billed at the time of service to the credit card provided. **SEMEN WILL NOT BE RELEASED BY BRAZOS VALLEY EQUINE HOSPITALS UNTIL THE ACCOUNT IS PAID IN FULL.**
- 4. To obtain a “breeder’s certificate” you must notify Brazos Valley Equine Hospitals of the birth of the foal. Certificate will not be issued if the account has not been paid in full. The stallion owner is responsible for signing the breeder’s certificates.
- 5. Any dispute related to this contract will be governed by the laws of the State of Texas and venue of any dispute arising from this Contract shall be in Grimes County, Texas.
- 6. This contract is non-transferable nor assignable without prior written consent from BRAZOS VALLEY EQUINE HOSPITALS.
